PUBLIC NOTIFICATION – April 5, 2019

Dr. PHILLIPS, Gregory Lorne Vancouver, BC

If reporting on this public notification, please provide the name and location of the physician in full in order to avoid confusion with any other physician who may have a similar name or initials.

1. **Nature of action:** The Inquiry Committee of the College of Physicians and Surgeons of BC conducted an investigation into the conduct of Dr. Gregory Lorne Phillips, pursuant to section 33(4) of the *Health Professions Act*, RSBC 1996, c.183.

The Inquiry Committee and Dr. Phillips have agreed to resolve all matters arising from the investigation by way of a Consent Agreement under section 37.1(3)(a) of the *Health Professions Act*.

2. **Effective date:** February 20, 2019
3. **Name of registrant:** Gregory Lorne Phillips
4. **Location of practice:** Vancouver, BC
5. **Admission and acknowledgements:** Dr. Phillips has admitted to and/or acknowledged the following:
 - (a) That he failed to respond to multiple communications from the College, contrary to section 4-11 of the Bylaws made under the *Health Professions Act*; and
 - (b) That he made misrepresentations to the College to secure an adjournment of a disciplinary hearing scheduled for December 7, 2018.
6. **Disposition:** Following the issuance of a disciplinary citation pursuant to section 37 of the *Health Professions Act*, Dr. Phillips entered into a Consent Agreement with the Inquiry Committee of the College of Physicians and Surgeons of BC, wherein he has consented to the following terms, pursuant to section 39(2) of the *Health Professions Act*:
 - (a) To be transferred from the Full – General/Family class of registration to the Conditional – Disciplined class of registration;
 - (b) To a formal reprimand;
 - (c) To a fine in the amount of \$10,000;
 - (d) To a suspension from the practice of medicine for one month;
 - (e) To undertake to respond to College communications within four weeks of a request for response;

- (f) To engage with the College's Physician Practice Enhancement Panel; and
- (g) To pay \$11,000 towards the College's cost of the investigation.

7. **Rationale:** The Inquiry Committee was critical of Dr. Phillips failure to respond to College communications. Given the importance that must be placed on physicians being responsive and truthful to the regulator, the Inquiry Committee determined a disciplinary outcome was appropriate.

The College of Physicians and Surgeons is the licensing and regulatory body for all physicians and surgeons in the province. Governed by provincial legislation, the College's role is to protect the public by establishing, monitoring and enforcing high standards of qualification and ethical practice across the province.
