

Disciplinary outcomes

In 2019/20, six disciplinary matters were concluded.

APRIL 2019

Dr. Viem Chung Nguyen Vancouver, BC

Dr. Viem Chung Nguyen failed to respond to College communications contrary to section 4-11 of the College Bylaws. Dr. Nguyen was transferred to the conditional – disciplined class, reprimanded, fined \$7,500, provided an undertaking to respond to College communications within four weeks of a request for a response, and was required to pay costs of \$8,731.76.

Dr. Gregory Lorne Phillips Vancouver, BC

Dr. Gregory Lorne Phillips failed to respond to College communications contrary to section 4-11 of the College Bylaws and made a misrepresentation to the College to secure an adjournment of a disciplinary hearing. Dr. Phillips was transferred to the conditional – disciplined class, reprimanded, fined \$10,000, suspended for one month, provided undertaking to respond to College communication within four weeks of a request for a response, engaged with the Physician Practice Enhancement Program, and paid \$11,000 in costs.

JUNE 2019

Dr. Daniel Archie Buie Victoria, BC

Dr. Daniel Archie Buie breached conditions on his practice to practise only in a setting and location approved by the College, to have signs conspicuously posted in the office reception area and exam rooms clearly stating a chaperone will be present throughout all complete physical exams, all breast, pelvic or otherwise sensitive exams of female patients and all exams requiring patients to disrobe, and notify all clinical staff and medical staff at his practice setting of the conditions on his practice. Dr. Buie was transferred to the conditional – disciplined class, reprimanded and suspended for two months.

DECEMBER 2019

Dr. Johannes Hendrick van Eeden Vancouver, BC

Dr. Johannes Hendrick van Eeden committed conduct unbecoming a physician by providing medical services to an individual with whom he was in a personal and intimate relationship by prescribing various medications for the individual

and providing a doctor's note to the individual regarding absence from work. Dr. van Eeden was transferred to the conditional – disciplined class, reprimanded, suspended for six months (with four months stayed if certain terms and conditions are met), required to complete a multidisciplinary assessment program, required to attend an interview at the College with registrar staff, and comply with monitoring of his practice by the College.

Dr. Vincent Arguelles Zenarosa Nelson, BC

Dr. Vincent Arguelles Zenarosa committed unprofessional conduct by administering Botox to a patient without supervision when he was not licensed to practise in BC and his clinical trainee licence had expired. If Dr. Zenarosa reapplies for licensure in BC, he will be placed on the conditional – disciplined class, will be reprimanded and will attend continuing medical education in ethics and professionalism.

FEBRUARY 2020

Dr. Daljit Singh Herar Abbotsford, BC

Dr. Daljit Singh Herar breached conditions on his practice to see no more than 40 patients a day, to practise only six days a week, and that he notify all physicians and clinical staff at his practice location of the terms and conditions on his practice. Dr. Herar was fined \$40,000, suspended for one day, received a formal reprimand, paid costs of \$10,000, and remains on the conditional – disciplined class of registration.
